# COMPLEMENT™

**Directions for Use**  
**Use only as directed.**

First mix the herbicide, SERVIAN® with water and then add COMPLEMENT to the mixture.

Use 0.5 lt./ha COMPLEMENT with 50 g/ha SERVIAN®

**Storage**

Store away from food and feeds. Keep out of reach of children, unauthorised persons and animals.

**Precautions**

Maintain all precautions that apply to the herbicide, SERVIAN®, with which COMPLEMENT is to be used. Wash with soap and water after use; eyes, rinse with plenty of water. If irritation persists see a doctor. Rinse the empty containers three times with a volume of clean water equal to a minimum of 10% of the container. Add the rinsate to the contents of the spray tank before destroying the container, either by burning or burying deep in the ground away from water sources.

Do not use the empty containers for any other purpose, especially not for storing drinking water, food or feed.
